Voting

Voting will take place if at the time of the general membership meeting there are one or more contested officer positions. Only members in good standing may vote for officers. If voting for any position is needed, it will be by voice vote by members in attendance, either in person or using remote participation. The rules for voting may change if deemed necessary by the chair. (Example: if voice vote is inconclusive.)

If no races are contested and voting is unnecessary, those in attendance may move to accept the slate of officers as a whole.

The first ever Wisconsin Senior Summit was held on Thursday, Nov. 6 from noon to 4 pm at the Holiday Inn Convention Center in Stevens Point. Tom Kriegl and I were part of the 5-county coalition that planned and hosted it. About 75 people attended, including 16 from our group! Thank you to Brad and Kim Horner, Ken and Sue Kidd, Joe and Jean Scolaro, Dick Anfang, Marilyn Kharbush, Dan and Cathy Holzman, Mary Friesen, Damian Barta, Joanne Bieseck, and Joice Meyer for participating! Topics covered included: the status of seniors and senior care in WI, the federal Budget Reconciliation bill and its consequences for WI seniors, how to be a ombudsman for your local nursing home, how to save your county nursing home from being privatized, and taking action regarding senior care in WI and our country.

There are actually two meetings that night. The first meeting is consideration of the proposed 2026-2028 budget. There will be time for public comment. PLEASE attend, wear your Citizens for the SCHCC" t-shirt (I will also bring signs), and consider saying something to this effect:

"I strongly favor a county budget that fully supports our SCHCC, and I am totally opposed to a budget that continues to overstaff our jail. We cannot afford to do both. I urge the Board to vote accordingly."

The second meeting is the general meeting. At the end of the agenda, it states that the Board may go into closed session to consider a lawsuit filed against them by a group called Voces de La Frontera. This lawsuit was brought against the county because it is housing ICE detainees in our county jail. These detainees, under the Trump Administration, are not being provided due process rights when they are apprehended, rights which are guaranteed under our U.S. Constitution.

So, if that is of concern to you, please stay and you can speak to that issue during the public comment portion of that second meeting. I plan to do so, and others from our SCHCC group may do so as well.

I look forward to seeing you Tuesday night. We can gather on 3rd floor outside the Boardroom at 5:45. If you plan to speak during public comment for one or both meetings, you will need to complete a form just before the meeting and hand it to the County Clerk, Becky Evert, who is seated at the front of the Boardroom.
